**Notification of Vacancy for Recruitment of Full time / Part time teaching
Posts (Purely on temporary basis for the Academic Year 2023-24)**

1. Full-time teacher in Sanskrit – Two posts (Rs.20,000 per month)
2. Part-time teacher in Environmental Studies - One Post (Rs.1500/- per lecture to a maximum of 50 lectures in Academic session 2023-24, per year)

Essential Qualification:

For Sanskrit Post: -

- (i) A Master's degree with 55% marks in Sanskrit / Acharya (or an equivalent grade in a point-scale wherever the grading system is followed) in concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET :

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

OR

B. The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

General conditions:

1. The latest passport size photograph of the candidates should be affixed to the application form.
2. The Adarsh Sanskrit Mahavidyalaya reserves the right to fill up or not to fill up the post without assigning any reason.
3. Candidates will have to present themselves for the interview/Written test at their own expenses.
4. Candidates should bring all certificates in original at the time of interview.
5. The appointee will be the employee of Mumbadevi Adarsh Sanskrit Mahavidyalaya, Dr. Kulapati Munshi Marg, Mumbai - 400007 and not of Govt. of India or Central Sanskrit University, New Delhi. They will be governed by the provisions of the scheme as applicable from time to time.
