**NOTIFICATION**

**Whereas**, the Central Government is empowered under Section 3 of the University Grants Commission (UGC) Act, 1956 to declare, on the advice of the UGC, an institution of higher learning as a deemed-to-be-university.

2. **And whereas**, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government vide its Notification No.9-28/2000-U.3 dated 07.05.2002, on the advice of UGC, had declared Rashtriya Sanskrit Sansthan, New Delhi consisting of its eight multi-campus located at Lucknow, Allahabad, Jaipur, Sringeri, Trichur, Puri, Jammu & Garil (Kangra, Himachal Pradesh) as an "Institution Deemed to be University", subject to a review after five years. And further whereas, the Central Government, vide Notification No. 9-28/2000-U.3 dated 01.01.2009, on the advice of the UGC, extended the status of Deemed to be University of Rashtriya Sanskrit Sansthan, New Delhi for a further period of five years i.e. upto 06.05.2012.

3. **And whereas**, the Central Government, vide Notification No. 9-28/2000-U.3 dated 30.06.2009, on the advice of the UGC, permitted Rashtriya Sanskrit Sansthan (Deemed to be University), New Delhi to bring the Bhopal and Mumbai Campus under its ambit as constituent teaching units. And further whereas, the Central Government, vide its Notification No. 9-28/2000-U3(Pt.1) dated 13<sup>th</sup> February, 2019, extended the status of Deemed to be University of Rashtriya Sanskrit Sansthan, New Delhi from 07.05.2012 onwards.

4. **And whereas**, Rashtriya Sanskrit Sansthan, New Delhi submitted an application for starting of an Off-Campus Centre at Agartala, Tripura. The application was forwarded to UGC for examination and advice. UGC examined the application with the help of its Expert Committee. The report of Expert Committee was considered by the Commission in its 503<sup>rd</sup> meeting held on 22.09.2014 and recommended for approval the proposal for establishing of off-Campus centre of Rashtriya Sanskrit Sansthan at Agartala, Tripura. The said recommendation of UGC was conveyed to Rashtriya Sanskrit Sansthan, New Delhi by this Ministry on 5<sup>th</sup> December, 2016.

5. **Now, therefore**, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government, on the advice of the UGC, do hereby accord its approval on the proposal of Rashtriya Sanskrit Sansthan, New Delhi to establish an Off-Campus Centre at Agartala, Tripura w.e.f. 5<sup>th</sup> December, 2016.

6. The declaration, as made in Para 5 above, is further subject to the following conditions:

- i. The over-all performance of Agartala (Tripura) Campus shall be monitored by the Commission biennially for six years and subsequently as per the provisions of the existing Regulations and whose directions on management, academic development and improvement shall be binding on the Constituent Institution.
- ii. All the earlier conditions that were stipulated in this Ministry's Notifications shall be adhered to by the Institution deemed to be University.
- iii. The entire moveable and immovable assets/properties as well as the existing manpower of the Agartala (Tripura) Campus shall be registered in the name of the deemed to be University.
- iv. There shall be no diversion of assets or funds/revenues of the Institution Deemed-to-be-University/or of its Off-Campus(es), without prior permission of the UGC.
- v. Rashtriya Sanskrit Sansthan (Deemed to be University), New Delhi as well as its Off-Campus(es) shall not engage or indulge in any activities that are of commercial and profit making in nature.
- vi. The academic programmes offered/to be offered at the Off-Campus(es) of the Institution deemed to be University shall conform to the norms and standards prescribed by the UGC and other Statutory Councils concerned.
- vii. The Institution deemed to be University shall take appropriate steps to commence research programmes as well as doctoral and innovative academic programmes at all its Off-Campuses.
- viii. All the prescribed norms and procedures of the UGC and other Statutory Councils concerned in the matter of admission of students, intake capacity of students, renewal of approval to the academic course / programme, revision of intake capacity of students, starting of new courses / programmes, etc. shall continue to be in force, and shall be adhered to by Rashtriya Sanskrit Sansthan (Deemed to be University), New Delhi and its Off-Campus(es).
- ix. As and when necessary, Rashtriya Sanskrit Sansthan (Deemed to be University), New Delhi shall update or revise or modify its Memorandum of Association (MoA) / Rules in accordance with the UGC (Institutions Deemed to be Universities) Regulations, 2019, as amended from time to time.

- x. Rashtriya Sanskrit Sansthan (Deemed to be University), New Delhi shall adhere to the instructions of the UGC as contained in the UGC (Institutions Deemed to be Universities) Regulations, 2019.


