

Shri Dharmendra Pradhan ji,

I would like to apprise you that the Government of India is promoting plantation activities through various policies and schemes to enhance forest and tree cover in the country. The Nagar Van Yojana (NVY) is one of the initiatives of the Ministry towards achieving the green goal of the nation in consonance with the National Forest Policy. The primary objective of this scheme is to create forest/ green spaces in urban areas by developing Nagar Van/ Vatikas and to protect forest land within cities/towns or its fringes from degradation and encroachment. The scheme is designed to actively engage local residents and different agencies in developing biodiversity in forests for social and environmental benefits in an urban landscape.

We have envisioned development of 1000 Nagar Vans/ Vatikas under this scheme and 250 Nagar Van/ Vatika projects have been sanctioned in 29 States/ UTs of the country till now. NVY is being implemented with funding from National Authority of Compensatory Afforestation Fund Management and Planning Authority (CAMPA). To enhance the ambit of the scheme and to cover more area, now it has been envisaged to allow development of Nagar vans within 10 km of the Municipal limits.

The Ministry of Education runs several educational institutions across the country, some of which are spread over a large area of land within the urban limits. The development of Nagar Vans/ Vatikas on such areas will not only enhance green cover but also increase awareness among the students besides reducing pollution levels. This ministry will provide the necessary support for creating Nagar Van/ Vatika projects and the detailed Guidelines of NVY are available on the website of the Ministry.

I would be grateful if you direct the concerned Departments of your Ministry for developing Nagar Vans/ Vatikas in the institutions of national importance such as IITs, IIMs and Central Universities and other institutions in coordination with forest department of the States/ UTs.
