Dear Si,

I take this opportunity to bring to your kind notice that the National Human Rights Commission of India came into existence on 12th October, 1993 pursuant to the promulgation of Protection of Human Rights Act, 1993 and in consonance with Paris Principles for better protection of human rights.

- 2. Further, as per Section 12 (g) of the PHR Act 1993, the Commission shall perform to undertake and promote research in the field of human rights. Accordingly, research studies in the field of human rights are being conducted by the Commission in collaboration with Universities, Technical Institutions and Non-Governmental Organizations on the various subjects of human rights relating to life, liberty, equality and dignity of the individual guaranteed by the Constitution or embodied in the International Covenants and enforceable by courts in India.
- 3. In the Research Division of the Commission total 09 posts in various grades have been sanctioned by the Government out of which 06 posts are vacant due to non availability of eligible officer in feeder grade for promotion and repatriation of existing incumbents. Due to large number of vacancies the research related work of the Commission is being adversely affected.
- 4. As per existing recruitment Rules, these posts are required to be filled up by deputation basis. The vacant posts have been advertised several times inviting application from the willing and eligible officers on deputation basis but due to non sponsoring of eligible candidates by the various Ministries/Organizations these posts could not be filled up.
- A copy of vacancy notice including eligibility criteria for selection of officer to these posts on deputation basis as prescribed in exiting Recruitment Rules is annexed. The last date of receipt of application is 15th February, 2024.
