During the meeting it was decided that:-

The Sansthan must aim to complete all the requisite formalities by 10th of May, 2018, so that the
application for accreditation is made during the May-June window.

 All the Principals of the Campuses of the Sansthan, along with the respective coordinators be asked to make a presentation (SSRs and Video Presentation of 15 minutes duration) of their respective campuses before the NAAC Standing Committee at the Sansthan Headquarter, New Delhi, on April 26-27, 2018. In case of any query, doubt or difficulty, the campus coordinators may contact Director, IQAC, Prof. Sudesh Kumar Sharma.

 All the Campus AQARs for the previous five years, namely, 2012-13, 2013-14, 2014-15, 2015-16 and 2016-17 should be ready and posted on the respective campus websites on or before 25.04.2018.

4. Dr. R.G. Murali Krishna should be appointed as Coordinator, Delhi Campus (HQ) and entrusted the task of preparing the AQARs and SSR of the Delhi Campus (HQ) before the expiry of the deadline.

5. If needed, Dr. Mantha Shrinivasu be provided technical support for uploading the material related to SSR.

As the UGC has already sent its approval of the Agartala Campus, efforts should be made to get MHRD issue the Notification in the same regard so that the relevant data could be included in the AQARs and the SSR.

7. All the work relating to the IIQA should be completed on or before May 10, 2018.

8. Submission of AQARs by the campuses on or before September 30 every year should be made a regular feature and as such should be institutionalized as an annual feature in the Sansthan calendar.
