

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is entered on 06.06,2022 by and between:-

- (i) Central Sanskrit University (here referred to as "University") 56-57, Institutional Area, Janakpuri, New Delhi 110 058.
- (ii) Information and Library Network (herein referred to as "INFLIBNET"), An Inter University Centre of UGC, Govt. of India located at Gandhinagar, Gujarat- 382007.

University and INFLIBNET are referred to individually as "Party" and collectively as "Parties". Both parties have reached the following broad areas of cooperation & collaboration intent:-

WHEREAS University, is a University established by an Act No.5 of 2020 passed by the Parliament with its object to disseminate and advance knowledge by providing instructional, research and extension facilities to the promotion of Sanskrit Language and such other branches of learning as it may deem fit; to make special provisions for integrated courses in humanities, social sciences and science in its educational programmes; to take appropriate measures for promoting innovations in teaching-learning process and inter-disciplinary studies and research; to educate and train manpower for the overall development, promotion, preservation and research in the field of Sanskrit and Sanskrit traditional subjects as approved time to time by the academic council of the university.

AND WHEREAS INFLIBNET Centre, an Inter-university Centre of the University Grants Commission of India under Ministry of Education, Govt. of India undertakes activities and services of the Centre which include, automation of academic libraries and information centres, providing access to subscribed and open access e-resources, e-content, ranking of institutions, development of web applications to facilitate scholarly communication and maintenance of bibliographic and non-bibliographic database, etc.;

Purpose and Objective

The Learning Management Service is one of the mode of learning which facilitate learners and teachers to execute the learning environment. The INFLIBNET Centre has been working as a facilitator for setting-up INFLIBNET Learning Management Service (ILMS) with prepopulated e-content developed under e-PG Pathshala and other available open access content with an aim to make all the e-content available to the academic and research community. The Centre is providing ILMS service to the Indian Universities/Institutions on request basis.

Roles and Responsibilities

1. INFORMATION AND LIBRARY NETWORK CENTRE (THE INFLIBNET CENTRE)

The broader role and responsibility of INFLIBNET are as follows:

- 1.1 Shall implement/setting-up the ILMS using open-source software with functions and features that are expected in a modern day LMS on university server.
- 1.2 Shall customize the ILMS (look & feel, theme, banner, logo, etc);
- 1.3 Shall integrate, on request basis, course content developed under e-PG Pathshala (700+ PG courses);
- 1.4 Shall provide help manual / video tutorials for its stakeholders;
- 1.5 Shall provide one-day training on mutual consent;
- 1.6 Shall provide hosting facility on their services of ILMS on charge basis, if university is unable to provide the server;
- 1.7 Shall provide maintenance service on charge basis.

2. University

The broader role and responsibility of University are as follows: -

- 2.1 Shall provide server, pre-requisite configuration, to set-up ILMS
- 2.2 Shall request to provide hosting facility (charge basis) of ILMS to INFLIBNET in case of non-availability of server at University.
- 2.3 Shall obtain sub-domain name with "ilms.university name"
- 2.4 Shall create / enrol users and its management
- 2.5 Shall create course content as per university requirement
- 2.6 Shall keep regular back-up and hardware/software related responsibilities.
- 2.7 Shall provide the locally developed content, on mutual consent, to INFLIBNET Centre to host on open access platform, developed by the INFLIBNET Centre.
- 2.8 Name of the party shall claim ownership of the e-content. The ownership of the e-content shall waste the actual owner of e-content.
- 2.9 Shall arrange capacity building programmes for stakeholders, if required.

3. Financial Implication

There is no financial implication to the University except in cases below:

- (i) Hosting service of ILMS through INFLIBNET Centre, if required by University:- The charges started from Rs.5000/- per month. Further, changes in charge shall depend on demand of server configuration.
- (ii) Yearly maintenance charges for following services:
 - a. Integration of open access course content available under INFLIBNET e-Content repository
 - b. Periodical backup
 - c. Trouble shooting
 - d. Additional training to its stakeholders
 - e. Bulk registration/assist admin for smooth functioning

The yearly maintenance charge of maintenance service shall be Rs.25000/- payable in advance up till 15th day of April of every Financial Year (Subject to revision of current charge). The hosting charges shall be paid in advance for a period of three months in total up till 15th day of every commencing quarters of English Calendar year.

4. RELATIONSHIP

This MoU between the INFLIBENT and **University** is on principle of Service Provider (INFLIBNET Centre) basis and nothing in this MoU shall constitute or deemed to constitute a partnership between any of the Parties hereto.

5. TERMINATION

Both parties will have rights to terminate this MoU at any time in case of breach of obligations and terms and conditions of the MoU. The MoU signed hereunder may be terminated by either party upon thirty (30) days prior written notice.
