Subject:- Notification of review and revision of guidelines of Central Schemes for Promotion of Sanskrit and invitation of online applications for providing financial assistance for the financial year 2022-2023.

The guidelines of various Central Schemes of the Ministry of Education, Government of India, implemented by the Central Sanskrit University, Delhi for the Development of Sanskrit Education are being revised and reviewed from time to time. In this process the guidelines of Schemes for Development of Sanskrit Education in force till the financial year 2020-2021 have been reviewed as per norms. The reviewed/revised guidelines of the Schemes for Development of Sanskrit Education have been approved by the Ministry of Education, Government of India and renamed as "Schemes for Sanskrit Promotion (संस्कृतसंवर्धनयोजना)". These revised guidelines are published and available on the website of the Central Sanskrit University at www.sanskrit.nic.in/schemes. The revised and approved guidelines have come into force from 01-10-2022. Therefore, the revised and approved new guidelines, the increased grant amount and other rules etc., are applicable from 01-10-2022.

Accordingly, application forms are being invited from 07-11-2022 through online mode for providing financial assistance under various Central Schemes for the year 2022-2023 from NGOs/Voluntary Organizations/Institutions/Universities/Publishers/Individual/Students, as per approved guidelines. The start date of online registration is 07-11-2022 and the last date is 10-12-2022. Last date for the Meritorious Scholarships is 31-01-2023.

In this regard, an advertisement has been published in various daily news papers/Sanskrit magazines across the country and website of the University on 06-11-2022. A copy of the advertisement is enclosed with this notification. As per the revised guidelines, it is mandatory to submit applications through online mode for financial assistance under the schemes. Applications sent before the publication of the advertisement dated 06-11-2022 and applications submitted through any other mode except online will not be considered under any circumstances. No institution is automatically renewed by the University for the financial assistance under any of the scheme. Therefore it is mandatory for the institution to apply every year for renewal as per the rules. As per the prevailing rules of Central Schemes, it is mandatory to submit a separate application for financial assistance only after the publication of the advertisement in every year. Financial assistance for the year concerned is not sanctioned in case of non-submission of application in any particular year as per rules. Financial assistance will be given subject to availability of the funds in each financial year. The financial grant of previous years will not be sanctioned in the next/coming financial years.

In case of any candidate/Institution has deprived of getting financial assistance for the year 2022-23 due to non-submission of application in accordance with the rules by any institution then responsibility will be lie with the concerned Institutions/College/University/Individual/Student only but not the Central Sanskrit University, Delhi.
