However as per guidelines of the concerned scheme, it is required to submit hard copy of publications/books/necessary documents alongwith hard copy of their online filled application duly certified by the Competent Authority, separately by Registered post, latest by 20-09-2023 to "**Director (Central Schemes), ...(Scheme name)..., Central Sanskrit University, 56-57, Institutional Area, Janakpuri, New Delhi – 110058**". Before filling the application form, the scheme guidelines should be referred.
