As you might be aware that besides its teaching and research activities, Central Sanskrit University has been entrusted with implementation of different central schemes for Development of Sanskrit Education. Under these schemes, financial assistance is provided to individuals/scholars/institutions/organizations engaged in propagation and development of Sanskrit throughout the country. Accordingly, one of the schemes i.e. **SCHEME FOR FINANCIAL ASSISTANCE TO INSTITUTIONS RECOGNISED AS ADARSHA SANSKRIT MAHAVIDYALAYAS/ADARSH SHODHA SANSTHANS** is being implemented by Central Sanskrit University, Delhi. Under this Scheme, there are 26 institutions situated at different parts of the country which have been granted recognition. The recognized institutions are getting 95% recurring and 75% non-recurring grant on approved expenditure. These institutions are engaged in imparting education from Prakshastri (12th standard) to Acharya (M.A. in Sanskrit) and at Research level.

Central Sanskrit University, New Delhi invites the applications/nominations from scholars/University Authorities for inclusion of names in the panel for nomination of Chairperson of Adarsh Sanskrit Mahavidyalaya(ASMs) / Adarsh Shodha Sansthans (ASSs). The qualifications other eligibility criteria etc. details are as follows:-

- 1. **Experience:** The Chairperson of the Management Committee of the ASM/ASS should be a person with at least 7 years of experience of having worked as Professor in a University/Principal in a PG College.
- 2. **Salary/Remuneration**:- The Position of Chairman is honorary and does not carry any salary/remuneration.
- 3. Functions/Duties of the Chairperson:
 - a) To preside over the meetings of the Management Committee.
 - b) To advise the Director/Principal on his request for efficient functioning of the institution.
 - c) To act as the Appointing Authority for Group A and B employees.
 - d) To act as an Appellate Authority for Group C & D employee.
 - e) All other condition as per Provision of Revised Scheme for Financial Assistance to Institutions Recognised as Adarsha Sanskrit Mahavidyalayas / Adarsh Shodha Sansthans - 2012 or as per revision of this scheme from time to time.

- 4. How to apply:- The application alongwith Bio-data duly signed by the candidate in the prescribed form should reach through speed post to the "Vice Chancellor, Central Sanskrit University, 56-57, Institutional Area, Janakpuri, New Delhi-110058 or through e-mail: adarsh@csu.co.in or any Authority like Vice-Chancellor, Registrar, Dean, Head of the Department may send nominations of any eligible professor with candidate's Curriculum vitae (CV) latest by 20/03/2022.
- 5. Selection Process:- As per approved guideline of the Scheme, The Executive Council of the Central Sanskrit University, Delhi will approve a panel of name of nomination for the Chairperson of the Management Committee of the ASMs/ASSs. The Vice Chancellor of the Central Sanskrit University shall nominate the Chairperson of ASM/ASS out of this panel as and when required.
- **6.** Nominated Chairperson shall contribute his/her services in any of the ASS/ASM situated at different parts of the country.
- 7. The candidate must super-scribe on the envelope as "Application for the nomination of Chairperson of Adarsh Sanskrit Mahavidyalaya(ASMs) / Adarsh Shodha Sansthans (ASSs)" or Email with subject "Application for the nomination of Chairperson of Adarsh Sanskrit Mahavidyalaya(ASMs) / Adarsh Shodha Sansthans (ASSs)".
- **8. Age limit:-** Not more than 70 years of age as on closing date of receipt of applications as prescribed in the Advertisement.

- **10.** The information relating to nomination will be communicated through email/postal to concerned candidate.
