- (a) He shall be entitled to be present at, and address, any meeting of School Board or Board of Studies, but shall not be entitled to vote thereat unless he/she is a member of such authority or body.
- (b) He shall supervise the academic activities of the University including designing new Academic Programmes in coordination with schools and departments. He/she shall also coordinate proper conduct of Online Programmes. He/she shall promulgate Academic Calendar.
- (c) He shall supervise the admission of students to various Programmes offered by the University. At the time of admission, he/she shall ensure that a signed declaration from every student to the effect that he/she submits himself/herself to the disciplinary jurisdiction of the Vice-Chancellor and other authorities of the University, is obtained (Refer Statute 30(7)).
- (d) He shall supervise conduct of Guest Lectures, Seminars, Workshops, Curricular, Co-Curricular, Extra-Curricular activities etc. in the University.
- (f) He shall exercise general supervision over the Library and the Publication and Research Section of the University.
- (g) He shall arrange for Scholarships and Merit Awards to the students.
- (h) He shall also perform such duties and functions as may be assigned to him from time to time by the Vice-Chancellor.

In pursuance of issuing this notification, earlier office order no. 384 dated 05.03.2022, nominating therein Prof. Banmali Biswal as Director (Academic Affairs) stands withdrawn.
