**Institution of Distinguished Chair Professorships &  
Guidelines for “appointment” of faculty against Chair**

**Preamble:**

Universal high-quality education is the best way forward for developing and maximizing our country's rich talents and resources for the good of the individual, the society, the country, and the world. The rich heritage of ancient and eternal Indian knowledge and thought has been a guiding light for National Education Policy, 2020. The importance, relevance, and beauty of the classical languages and literature of India also cannot be overlooked. Sanskrit, while also an important modern language mentioned in the Eighth Schedule of the Constitution of India, possesses a classical literature that is greater in volume than that of Latin and Greek put together, containing vast treasures of mathematics, philosophy, grammar, music, politics, medicine, architecture, metallurgy, drama, poetry, storytelling, and more (known as ‘Sanskrit Knowledge Systems’), written by people of various religions as well as non-religious people, and by people from all walks of life and a wide range of socio-economic backgrounds over thousands of years.

The National Education Policy envisions an education system rooted in Indian ethos that contributes directly to transforming India, that is Bharat, sustainably into an equitable and vibrant knowledge society, by providing high-quality education to all, and thereby making India a global knowledge superpower.

In view of above and also in a line with the vision of National Education Policy, 2020, eminent and competent faculty working/superannuated professors are appointed by Central Sanskrit University, New Delhi as University Chair Professors in order to meet higher quality benchmarks in teaching and research.

**1. Introduction:**

The following Chair Professorships are established in Central Sanskrit University, Delhi to bring a fresh flow of knowledge into its educational system with a view to blending various fields into Sanskrit.

- **Bharat Ratna Pt. Madan Mohan Malviya Distinguished University chair Professor (Indian Knowledge System)’**
- **Bharat Ratna PV Kane Distinguished University chair Professor (Multidisciplinary Studies)**

**2. Objective:**

To provide an opportunity to working professors/ superannuated teachers of recognised university and college/or from industry/Research institute/any National level Institution to pursue active research in Sanskrit Language or in their respective field/ interdisciplinary/Multidisciplinary field of his/her interest:

- To establish a new trend
- To achieve synergy
- To develop multidisciplinary research culture
- To recognise the distinguished contributions to Indian knowledge



### **3. Eligibility:**

The eligibility will be based on the quality of innovative research and published works contributed by the distinguished professors in his/her service carrier and with an outstanding track record in the designated area of studies. The awardee can work with a well-defined time bound action plan as per UGC standard/norms.

### **4. Designation:**

The faculty member who has been "appointed against the Chair" will be called "XXX Chair Professor".

### **5. Academic Functions:**

- To engage in research and, in turn, contribute to the advancement of knowledge in the area of the study.
- To strengthen the role of university/academics in public policy making.
- To design and execute short-term capacity-building programmes for teachers in higher education focused towards the designated discipline of the Chair.
- To provide a forum for inter-university/inter-campus Post Graduate and Research level dialogues, discussion meetings, seminars/summer & winter schools.
- To publish articles/research papers/reports/books/ monographs.
- To participate in teaching and Ph.D programme of the Department or School in which it is located.

### **6. Logistics support to the Chairs:**

The Chair should be located in one of the departments/ Centres or Schools at Headquarter Office or the Campuses of the University and shall be provided all the academic, administrative and logistic support extended to other Professors of the school/department.

### **7. Procedure for Application/Nomination/Selection:**

#### **7.1 APPLICATION:**

The candidate/professor/researcher can apply for the Chair Professorship against the advertisement through his/her institution or superannuated professor may directly apply with his/her credentials like best publications /research work.

#### **7.2 NOMINATION:**

By any Vice-Chancellor, Professor and Eminent Scholar Self-nominations will also be considered.

#### **7.3 SELECTION:**

Selection committee can consider any of the distinguished Professor known through his/her innovative Teaching/Publications/Research work.

### **8. Selection Committee:**

As per UGC norms for the post of Professor

## **9. Duration of the Chair:**

Two years (24 months) [can be extended for one more year depending upon review of research work by the review committee, subject to a maximum of 3 years and not exceeding 70 years of age]. Appointment of Distinguished Chair Professorships will be against the 02 sanctioned and vacant posts of Principal/Professor.

## **10. Salary and Perks:**

The distinguished University Chair Professor appointed by the Central Sanskrit University, Delhi shall be eligible for drawing the following Salary & Perks and other facilities:

- 10.1. In case of a working Professor, who has been appointed in the Distinguished Chair Professorship on deputation basis, after applying through proper channel will draw last pay drawn in the Parent University/Institution after protection of Pay along with five to ten advance increments/Or Pay of Senior Professor in Academic Pay Matrix Level - 15 (Rs. 1,82,200 to 2,24,100) along with five to ten advance increments, as recommended by the Selection Committee, which shall remain the same throughout the tenure of Chair Professorship. He/she will be eligible for HRA, Leave Facility, Medical Facility and LTC as applicable to regular teachers in the University.
- 10.2. In case of a superannuated Professor, he/she shall be eligible to draw emoluments equivalent to the last pay drawn minus pension as a consolidated amount, along with five to ten advance increments, as recommended by the Selection Committee, which shall remain the same throughout the tenure of Chair Professorship. He/she will not be eligible for any privileges as provided by the University to the regular teachers. However, he/she will be entitled for Casual Leave/Special Casual Leave/duty leave at par with as per regular teachers.
- 10.3. Distinguished Chair Professors will be provided with office space, office facility and working infrastructure, such as Computer, Printer and Stationary etc.
- 10.4. In any case, Distinguished Chair Professors will not be eligible for any Pension or other retirement benefits and Leave Encashment, etc. from Central Sanskrit University.

## **11. Reporting:**

The selected distinguished University Chair Professor will be responsible to the Hon'ble Vice Chancellor, CSU, Delhi for his/her works as Distinguished Chair Professorship.

## **12. Any Other:**

The university will evolve a mechanism to review the progress of the Chair annually.

## **13. Grievances:**

Guidelines to handle disagreements and any grievances (including financial payments, discontinuation of the Chair etc.) would be handled as per the norms laid down and adopted by CSU.

15. These guidelines are subject to revision from time to time as per the need by the Vice-Chancellor and/or Executive Council. The final guidelines will be notified in the University Official Website.
