### Illustrative List of Activities to be performed during JJGD

- i. The activities would be from 15th November to 26th November, the Constitution Day.
- ii. Need to organize JJGD in a graceful manner, with active participation of all stakeholders.
- iii. The celebration should not be an end in itself but should lead to active participation in outcomeoriented creative activities related to improvement in education, health and livelihood aspects. Preservation and promotion of tribal culture would also be a significant part of the celebrations.

### Organization of activities such as:

- a. Floral tributes to Bhagwan Birsa Munda and other tribal freedom fighters.
- b. Organization of seminars, workshops on matters pertaining to tribal development and welfare, and protection of environment
- c. Honouring of tribal achievers, including outstanding tribal scholars and students.
- d. Outreach activities to the tribal communities by students
- e. Commencement of a sustained engagement by faculty and students, with tribal communities through mentoring of schools/colleges/youth groups/tutoring/coaching for competitive examinations/career counseling etc
- f. Cultural events such as dance, drama, music, painting and other arts and crafts associated with tribal communities.
- g. Competitions and quizzes on various aspects of tribal matters
- h. Publication guidance for students, wishing to publish on tribal matters.
- i. Incubation guidance for tribal entrepreneurs, in the area of the expertise of the institution/University.
- j. Health camps and awareness camps.
- k. Encouragement to POSHAN vatikas in the institutions, as well as plantation activities.
