This is for information of all concerned that, vide letter F. No. 20-13/2024-CU.IV dated 20.08.2024 a directive from the Ministry of Education, Department of Higher Education, Government of India has been received, vide which it is instructed that all meetings of the University, including those of the Executive Council (EC), Finance Committee (FC), and other statutory bodies, shall be conducted exclusively within the premises University Campus.

Apart from the above all Principal/Principal In-charge/Directors/Director In-charge/of ASMs/ASSSs are also instructed that all meetings of Management Committee (MC), Finance Committee (FC) and other statutory bodies of the ASMs/ASSSs shall be conducted exclusively within the institutional premises. This measure is implemented to ensure transparency, accessibility, and operational efficiency while optimizing the use of University/Institutional resources.

All Campus Directors/Section Heads at Headquarters Office of Central Sanskrit University, Delhi and Principal/Directors of ASMs/ASSSs are hereby directed to adhere to these directives of Ministry of Education, Govt. of India. If there be a compelling need to hold any such meetings outside the institution, prior instruction alongwith detailed justifications must be given to Headquarters Office of Central Sanskrit University for further approvals. A copy of the above referred letter containing directives, is enclosed for compliance.


Subject: Holding of Meetings of Executive Council, Finance Committee, and Other Statutory bodies of Central Universities – regarding.
