- However, in view of the representations received from students and institutions regarding the said timetable, the rescheduled examinations issued on 26.05.2025, **is postponed**. These examinations are now tentatively scheduled to be held between 07th July 2025 to 13th July 2025. The revised timetable will be circulated shortly.
- In light of the exceptional circumstances that led to the postponement of these examinations, all Campuses & Institutes affiliated to the University are informed to ensure that the final-semester students should not be hindered in their pursuit of further education. Hence, such students should be permitted to get admission **provisionally** as per rule in the next academic programme for the session 2025-26.
