Sealed tenders are invited by Central Sanskrit University Bhopal Campus from interested and eligible firms for Event Management Services like Tent, Lighting, Sound, Live Telecast and Recording & Photos with Drone Camera services etc., during the 2-days Yoga Day-2026 (20th & 21st June) event at the Bhopal Campus under two Bid system i.e. (i) Technical Bid, and (ii) Price Bid.

2. 3. A non-refundable Tender Fees of **Rs. 1000/- (Rupees One Thousand Only)** is required to be deposited through Account Payee Demand Draft/ Banker's Cheque from any of the Commercial Banks in favor of Director, Central Sanskrit University, Bhopal Campus payable at Bhopal.
4. Tenders received after the due date and time shall not be accepted.
5. Technical Bids shall be opened on **09/06/2026 at 3.00 p.m.** in the presence of constituted committee of CSU Bhopal Campus and the representatives of tenderers.
6. Price Bid shall be opened for those tenderers only whose have been technically qualified by the Campus Committee.
7. CSU Bhopal Campus reserves the right to accept or reject any or all offers, without assigning any reasons thereof, before award of the contract.
8. The terms and conditions of the tender may be amended before the due date of submission. Bidders are advised to keep track on the website for any corrigendum/addendum issued.

1.0 Definitions:-

- "University Campus" shall mean "Bhopal Campus of Central Sanskrit University" and shall include their legal representatives, successors and permitted assignees.
- "Contract" means and includes the documents forming the tender and acceptance thereof together with the documents referred to therein including the conditions.
- "Firm" shall mean the Firm/ Entity applying in the tender process, its owner and shall include the legal representatives, successors and permitted assignees.
- "Competent Authority" means Competent Authority of the University.
- "Director" means Director of Bhopal Campus.

2.0 INSTRUCTIONS FOR BIDDERS:-

- All prospective tenderers shall submit their Bid in two separate envelopes super scribed as Envelope "A-Technical Bids" & Envelope "B-Financial Bids" which will be contained inside one big main envelope addressed to "Director, Central Sanskrit University, Bhopal Campus, Sanskrit Marg, Bagsewaniya, Bhopal-462043". The sealed envelope must be submitted/ reach on or before 06:00 p.m. on 08.06.2026. Each envelope shall be super-scribed as detailed below:-

- The Technical Bids shall be accompanied with proof of payment paid towards tender fees for the above mentioned empanelment. The tender fees is non-refundable.
- Price Bids shall be opened for those tenderers only which have been technically qualified by the Campus Committee.
- Tenders received without relevant documents as mentioned in tender document for meeting eligibility requirements shall not be considered for opening of Price Bid.
- The tenders shall remain valid for a period of 45 days from the date of opening the Technical Bid.
- Interested tenderers are requested to quote their **most competitive rates** (as per the format specified in **Schedule 'II'**).
- Technical & Price Bids shall have to be submitted in the Format as per **Schedule 'I'** and **Schedule 'II'/ Annexure-I** respectively.
- Conditional Bids or the Bids not accepting the terms and conditions will be rejected.
- The selected Bidders shall not assign or sublet this contract or any part of it to any other agency in any form. In the event of doing so, it shall result in termination of empanelment and forfeiture of Security Deposit along blacklisting the firm for a period of 01-year.
- The CSU Bhopal Campus reserves the right to modify and / or amend any of the above stipulated conditions / criteria depending upon its requirement. CSU Bhopal Campus also reserves the right to cancel the tender without assigning any reason thereof.

- The prospective tenderers should have the compliance of all the relevant Laws, Acts and regulations as applicable from time to time.
- In case of any clarification required, you may send your queries on email to director-bhopal@sanskrit.ac.in within 07 days of Bid publishing date.

3.0 Terms and Conditions for Tent, Light, Sound and Live Telecast During the Yoga Day Event at Bhopal Campus (20th & 21st June 2026)

- The applying agency must have the experience of conducting similar events at State/ National/ International Level. Detailed eligibility criteria is given at Clause No. 4 below.
- Rates should be quoted item wise for the articles as per Schedule-II. Any item may be added or deleted from the list of items as per requirement and payments will be made on actual basis, subject to verification of the work/ supply. Any items or work not included in the list, if needed, will be provided by the bidder and the amount for the same will be paid as per the most competitive market rates and mutual consents.
- **Tender will be evaluated on total cost basis. Rate of individual items will not be considered for evaluation of the proposals.**
- **Earnest Money Deposit:** - An amount of Rs. 25,000/- in the form of Demand Draft/ Banker's Cheque payable in f/o "Director, Central Sanskrit University, Bhopal Campus" must be submitted along with the Sealed Technical Bid. This amount shall be refunded in the event of rejection of the bid or alternatively adjusted in respect of successful bidder as part of Performance Guarantee
- **Performance Security:** - Successful bidder will have to deposit a Performance Security Amount in the form of Demand Draft/ Banker's Cheque payable in f/o "Director, Central Sanskrit University, Bhopal campus". The Performance Security will be 10% of the total work amount quoted by the bidder. The security amount is to be submitted before the award of work. No interest however will be payable on the deposit of Performance Security Deposit Amount. The said PG shall be released after successful completion of the event. In case the contractor fails to perform his contractual obligations successfully the performance guarantee shall be liable to be forfeited absolutely.
- **Physical Visit to the Site/ Location:-** Before submission of Bids, Interested Bidders may visit the actual site of work/ location (located at Central Sanskrit University, Bhopal Campus, Sanskrit Marg, Bagsewaniya, Bhopal-462043) during the office timing (10:00 a.m. to 06:00 p.m.) for actual site conditions and project requirement.
- **Delivery:** - The supplier will be responsible for the delivery of the goods and services in good condition and installation at their own risk and cost at the location of the function i.e. Central Sanskrit University, Bhopal Campus, Sanskrit Marg, Bagsewaniya, Bhopal, Madhya Pradesh-462043. All installations shall be put in order by 06:00 p.m. on 19/06/2026 and upto 09:00 p.m. on 21.06.2026. A penalty of Rs. 5,000/ – per hour per location shall be imposed for delay in completion of work as per the schedule above with a maximum limit upto Rs. 1,00,000/-.
- **Payment:** - Payment will be made through NEFT/RTGS only after conclusion of the event on submission of bill (subject to verification of the bill) and if the items/ services are found in good condition and there is no discrepancy of any nature. **No advance payment will be made.**
- **Penalty:-** Failure in any terms and conditions, and supply of unsatisfactory or inferior items/ services will attract penalty upto 10% of the total bill and the penalty amount shall be deducted from the bill and necessary action regarding blacklisting of the firm may also be initiated as per applicable provisions/ rules.
- Bidders responding to this enquiry shall be deemed to be aggregable to the terms and

conditions herein contained. These terms and conditions shall be binding on the successful bidders. Conditions bids are liable to be rejected.

- **Permissions/ Clearance:** - Agency shall obtain all required permissions from the local statutory authorities required for this work. All associated activities required for obtaining necessary clearances, permissions, approvals, all licenses etc. as required from all concerned authorities in respect of installation and commissioning shall be the responsibility of the contractor, the cost for which shall be deemed to be included in the rates.
- The contractor shall be bound to follow the instruction and restrictions imposed by the Administration / Police authorities on the working and movement of labour / material / vehicles etc. and nothing extra shall be paid on this account.
- The successful bidder shall make all arrangements towards safe and complete execution at the designated location as directed by officer in charge. Such responsibility on the part of the bidder will include taking care of insurance, freight, state level permits etc. as applicable.
- The venue of arbitration proceedings shall be Bhopal. The language of proceedings shall be English. The law governing the substantive issues between the parties shall be the Laws of India. All disputes are subject to Jurisdiction of Bhopal Courts only.
- The firm shall not cause any damage to the work. The cost of any damage done by the firm to the existing infrastructure of the Campus shall be borne by the defaulter with additional penalty as decided by the Director, Bhopal Campus.
- After the event, edited video of the entire event shall be submitted in MP4 or any other popular video format with HD or higher resolution. The content in soft copy along with the hard copy of the photographs of good quality should be provided to the office.

4.0 **ELIGIBILITY CRITERIA FOR BIDDERS:**

- The office of the firms/ agency must be located in Bhopal.
- The agency must be registered for PAN and GSTIN having valid PAN and GSTIN.
- The firm should have work experience of executing similar work orders of event management in two Central / State Government Department/ Organization/ Semi-Government/ Autonomous Bodies/ Universities/ Colleges/ Reputed Big Private Universities etc.
- Three similar works each costing not less than Rs. 8.50 Lacs, or two similar works each costing not less than Rs. 10.50 Lacs or one similar work costing not less than Rs. 12.50 Lacs. Similar work shall mean works of providing such event management services in the Central / State Government Department/ Organization/ Semi-Government/ Autonomous Bodies/ Universities/ Colleges/ Reputed Big Private Universities.
- The firm should not be blacklisted by Central/ State Government Department / Organization/ Autonomous Bodies/ University etc.,

5.0 **Documents to be accompanied (in the Technical Bid):**

The Technical Bid shall comprise of the following documents:-

6.0 Process of Selection: -

- Bids will be evaluated on the basis of terms and conditions already incorporated in the Tender Document, based on which tenders have been received and the terms and conditions mentioned by the bidders in the tender. No New Condition will be brought in while scrutinizing and evaluating the tenders.
- The Purchaser will examine the Bids to determine whether they are complete, whether the documents have been properly signed, stamped and whether the bids are generally in order.
- At the first stage, the Technical Bids will be evaluated by a duly constituted Tender Committee of the Campus. Financial Bids of only those bidders who have been technically qualified will be opened on the same day.
- The Financial Bids will be evaluated on the total cost basis. Rate of individual items will not be considered for evaluation of proposals. However, the decision of the Committee shall be final and binding upon the bidders.
- **Tender will be evaluated on total cost basis. Rate of individual items will not be considered for evaluation of the proposals.**

7.0 **Code of Ethics:** - The purchaser as well as the Bidder shall observe the highest standard of ethics including laws against fraud and corruption in force in India namely "Prevention of Corruption Act 1988", during the execution of such contracts. If the Bidders are found in Bid pooling, cartelization or against law on fraud and corruption then their firms may be debarred from participation in all the University tenders for three years.

8.0 DISPUTE RESOLUTION BETWEEN CSU BHOPAL CAMPUS AND TENDERER

1. AMICABLE SETTLEMENT:-

- The parties (i.e. CSU Bhopal Campus and Tenderer) undertake that any conflict or dispute that may arise between them shall first be dealt with in the manner stated below, irrespective of any other recourse, which any party may have in law or in equity.
- In the event of any conflict or dispute arising out of or in connection with the tender, the parties shall endeavor to settle such disputes amicably, if a dispute is not resolved within 30 (thirty) days after a written notice of any dispute by one party to the other, the same shall then be resolved through the mechanism of a Dispute Resolution Committee. This Dispute Resolution Committee shall comprise of representatives of both the CSU Bhopal Campus and tenderer and shall be chaired by the authorized representatives of CSU Bhopal Campus.

If the Dispute Resolution Committee is not able to resolve the matter within 30 (thirty) days of its formation, the dispute shall then be referred to Arbitration.

2. **ARBITRATION:-** In the event of any conflict/ dispute arising out of or in connection with the tender, which has not been resolved in accordance with the procedure laid down in clause 1 above, the aggrieved party may invoke Arbitration by sending a written notice to the other party. The procedure for appointment of the Arbitral Tribunal shall be as follows:-
- The matter shall be referred by either party to Director, CSU Bhopal Campus for appointment of Sole Arbitrator.
 - The venue of the Arbitration shall be at Bhopal and shall be governed by provisions of the Arbitration & Conciliation Act, 1996 as amended by the Arbitration & Conciliation (Amendment) Act 2015 (3 of 2016) and amended from time to time. The Arbitration proceedings can also be conducted in the English language.
 - The cost of the Arbitration shall be equally borne by both the parties.
 - The award of the arbitrator shall be final and binding on the parties.
3. The tender shall be interpreted and governed in all respects in accordance with the laws of India. All disputes in connection with or arising out of the tender, shall be subject to the exclusive jurisdiction of the Court at Bhopal.

In addition to above, CSU Bhopal shall be entitled to take such action as deemed fit and proper for recovering the said sum of Rs. _____

In case the contractor furnishes the bank guarantee at a later date the contractor hereby agrees to extend the validity of bank guarantee for such further period or periods as may be required by CSU Bhopal and if the contractor fails to obtain such extension(s) from the bank, the contractor shall pay forthwith or accept recovery of the amount of bank guarantee given in lieu of security deposit from the bills in one installment

and the contractor further agrees that failure to extend the validity of bank guarantee or failure to pay the aforesaid amount in the manner specified above shall constitute breach of contract. In addition to above, CSU Bhopal shall be entitled to take such action as deemed fit and proper for recovering the said sum.

5. That in consideration of the payments to be made to the Contractor by CSU Bhopal Campus in accordance with this Agreement the Contractor hereby covenants and undertakes with CSU Bhopal Campus that they shall execute, construct, complete the works in conformity, in all respects, with the terms and conditions specified in this Agreement and the documents governing the same.
