विषय/Subject: Integration of SC, ST, OBC, and PwBD Representatives in University Bodies and Committees - Regarding.


In pursuance of the directives and recommendations contained in the Report of the Hon'ble Parliamentary Committee on the Welfare of Scheduled Castes and Scheduled Tribes (2025-2026), 18th Lok Sabha, which was presented in both the Lok Sabha and Rajya Sabha on 18.03.2026, and various instructions from the Ministry of Education, Government of India, it is hereby notified for compliance by all concerned that Central Sanskrit University (CSU), Delhi, has institutionalized the Integration of representatives from Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (OBC), and Persons with Benchmark Disabilities (PwBD) across all Bodies and Committees of the University.

To uphold the constitutional values of equality, social justice, and inclusive governance as emphasized by the Hon'ble Parliamentary Committee, representatives from these categories must be actively integrated into the decision-making framework of the university. This measure is vital to address unique systemic challenges, ensure diverse participation in policy formulation, and robustly safeguard the institutional interests of these communities.

Accordingly, appropriate representation of SC, ST, OBC, and PwBD categories (comprising faculty, non-teaching staff, or students, as applicable under Govt. of India rules) must be strictly ensured in the following bodies of the University and its Campuses:

Consequently, all Directors of Campuses, Deans of Faculties, Heads of Departments, and Section Officers are hereby directed to immediately review the composition of their existing committees.
